**Meeting Location:** SFIREG will meet on Monday, June 3rd from 8:15 a.m. to 5:00 p.m. and Tuesday, June 4<sup>th</sup> from 8:15 a.m. until approximately noon. The meeting will be held in the 1<sup>st</sup> floor Conference Room, EPA's Office of Pesticide Programs facility, located at 2777 South Crystal Drive, One Potomac Yards (South Building), Arlington, VA.

**Hotel Reservations:** In preparation for the meeting, a block of rooms has been reserved under the designation of "AAPCO SFIREG Jun2019" at the Marriott Residence Inn Capital View Hotel, 2850 South Potomac Ave., Arlington, VA 22202. Please allow a 10-15 minutes extra time to pass through security at the entrance to the Potomac Yards building.

Use of an on-line "fare-watcher" may help minimize your airfare (realizing that each state's travel policies may dictate how tickets can be purchased). If you choose to come in on Saturday, please have materials to support your decision showing that hotel and per diem is less than travel on Sunday, and supply them with your travel voucher after the meeting.
